




School Nutrition Role:

 - 7 Residential Child Care Institute (RCCIs)






School Nutrition Role:

- I work on various Administrative Review (AR) Teams throughout the school year at geographical locations in all parts of the state of North Carolina






State of School Nutrition During Pandemic:

 - Loss of Valued School Nutrition Professionals






State of School Nutrition During Pandemic:

 - Boxed meals for up to a week






Challenges Now Being Experienced:

- Distributor concerns refusal to rollover existing contracts
- Menu planning






Challenges Now Being Experienced:

- Unfunded mandates for salary increases
- Not able to obtain USDA Foods
- In the state of North Carolina, October 2020 October 2021:
 - Breakfast meal counts are down 7%
 - Lunch meal counts are down 10%






Solutions for a Brighter Future:

- Support from district superintendents, principals, and administrators is critical to the success of your programs.
- Consider advance ordering of food and supplies to allow suppliers time to secure items or substitutions.
- o Discuss options with distributors when receiving "Out of Stock" Reports
- Building relationships with distributors, manufacturers, and all vendors is most important during these challenging times.






Solutions for a Brighter Future:

- Building relationships with distributors, manufacturers, and all vendors is most important during these challenging times.
- Use emergency and micropurchasing options when needed.
- Purchase local fresh fruits and vegetables.
- Consider increasing warehouse capacity by searching and securing unused facilities in the district.






Solutions for a Brighter Future:

- o If possible, rotate staff to allow staff members a "day off".
- Be flexible with distributors in receiving orders (late afternoons and weekends may be better options).
- Consider options for successful managers to manage multiple sites.
- Provide incentives for new and fresh ideas to improve your operations.



Consolidated schools – Student population: 194








Supply Chain Solutions

- Reduce number of deliveries when feasible –
 Work with your distributors to see if this impacts fees charged.
- Communicate needs and forecasts as early as possible.
- Plan your alternatives "what if" situations. When something doesn't show up, you already know what will happen.
- Communicate, communicate and communicate to your parents, administrations and all others.






Supply Chain Solutions
